

# Privacy Statement, Bromley Starter Packs

## 1. Statement of intent

The purpose of this statement is to be transparent about how the Bromley Starter Pack Scheme will collect, use and protect the personal information you provide to us.

Personal data is information that relates to identifiable living individuals. Bromley Starter Pack Scheme will act in accordance with current legislation and meet current best practice with regard to the processing of personal data. We are committed to safeguarding personal information.

### 1.1 Who we are

The Bromley Starter Pack Scheme is a project operated under the auspices of the Bromley Parish Church to help homeless people as they move into accommodation, giving preference to those who have a connection to the Bromley Borough.

The Charity generally provides:

- Bedding, Towels, Toiletries Crockery, Pots and Pans, and kitchen items

## 1. Collection of personal data

In any contact you have with The Bromley Starter Pack Scheme, you may provide certain personal data to us, which we will compile and process in accordance with this Privacy Statement. By providing such information you agree to its use and storage in accordance with the provisions of this Privacy Statement. For example, this might occur when you engage with our social media, make a donation to us, make use of our grant service, or volunteer. When you do so, we'll ask for personal information, like your name, email address and telephone number to store with your account.

Data protection law recognises that certain categories of personal information are more sensitive. This is known as sensitive personal data and covers health information, race, religious beliefs, criminal records and political opinions. Due to the nature of our work we may collect sensitive information on our referrals. In such an event, clear notices will be provided so that it is clear what information we need and why we need it.

## 2. How we use your personal data

Bromley Starter Pack Scheme shall only use your data for the purposes for which it is provided or where there is a lawful basis. For example by providing your name, address, email address and telephone number we are able to contact you about referrals, fundraising

activities, volunteering for the charity, donations and supporters schemes (e.g. Friends and Patrons).

When we collect and use your personal information, we will make sure this is only done in accordance with at least one of the legal grounds available to us under Data Protection law. One of these is where we have obtained your specific consent to use your information for a previously notified purpose, such as to send you email/text keeping you informed of our activities.

In certain instances, we may collect and use personal information where this is necessary in our legitimate interest as a charity, this includes being able to:

- Evaluate the necessity of providing a Starter Pack,
- Create anonymised demographic data for reporting purposes. or
- Maintain and administer our donor database and systems.

In all cases, we balance our legitimate interests against your rights as an individual and make sure we only use personal information in a way or for a purpose that you would reasonably expect in accordance with this Policy and that does not intrude on your privacy.

Where we process sensitive personal data (as mentioned above), we will make sure that we only do so in accordance with one of the additional lawful grounds for processing such as where we have your explicit consent or you have made that information manifestly public. When we do this, we will tell you what sensitive personal data we are collecting and why.

### 3. Marketing materials

We want to ensure you receive the level of information about Bromley Starter Pack Scheme that is right for you. If you actively provide your consent to us along with your email address we may contact you for marketing purposes by email. By subscribing to Bromley Starter Pack Scheme emails or opting in to email communication from the Bromley Homeless Shelter, you grant us the right to use the email for the purposes specified when you opt-in.

We will not use your personal information for email marketing purposes if you have indicated that you do not wish to be contacted by us for such purposes. However, we will retain your details on a suppression list to help ensure that we do not continue to contact you.

### 4. Third parties

We will only use your information within Bromley Starter Pack Scheme for the purposes for which it was obtained. Bromley Starter Pack Scheme will not, under any circumstances, share or sell your personal data with any third party for marketing purposes and you will not receive offers from other companies or organisations as a result of giving your details to us.

We may need to share your information with "data processors" such as our service providers, associated organisations and agents who help us to prepare and send the materials relating to our projects and fundraising activities. These "data processors" will only act under our instruction and we will not allow these organisations to use your data for their own purposes and will take care to ensure that they keep your data secure.

We will also comply with legal requests where disclosure is required or permitted by law (for example to government bodies for tax purposes or law enforcement agencies for the prevention and detection of crime, subject to such bodies providing us with a relevant request in writing).

## 5. Storage and correction of personal data

We will hold your personal information on our systems for as long as is necessary for the relevant activity, for example we will keep a record of donations for at least ten years. If you request that we stop sending you marketing materials we will keep a record of your contact details and appropriate information to enable us to comply with your request not to be contacted by us.

The accuracy of your information is really important to us. We want to ensure that we are able to communicate with you in ways that you are happy with, and to provide you with information that is of interest. If you wish to change how we communicate with you, or update the information we hold, then please contact us:

Under current data protection law you have the right to request a copy of the personal information we hold about you and to have any inaccuracies corrected. We require you to prove your identity with two pieces of approved identification.
